## NOTIFICATION

Vide the Gazette of India Extraordinary part-III, Section IV, Schedule 1/6 Scheme of Examination 6/4(d) at Page No.145 (English Version) published by the authority on Monday November 07, 2016 the Central Government made the regulations to amend the Indian Medicine Central Council Regulation 1986. As per the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016, the Hon'ble Vice-Chancellor, Shri Krishna AYUSH University, Kurukshetra has allowed one more chance i.e. Mercy Chance with Mercy Chance fee of Rs. 10,000 plus applicable examination fee of Rs. 5,000/- to the students of BAMS-1<sup>st</sup> Professional 2018 batch only to pass BAMS-1 Professional. These students, who avail this extra chance of appearing in the examination, shall not be allowed any more such extra chance during their remaining course of BAMS degree. All the Principals of the respective Ayurveda Colleges who have forwarded the list of affected students are requested to forward the duly checked and verified examination forms up to 03.08.2021 (for students) 05.08.2021 (for Colleges) of all such students who have exhausted their all the four chances to qualify BAMS-1<sup>st</sup> Professional. The students, who shall not submit their examination forms up to the above said date, have to pay late fee of Rs.3000/5000 whichever is applicable as per Ordinance.
